**Evaluation Methods Used:** This conformance report is based on the results of an accessibility audit performed internally by an Anthology Accessibility Tester, who is a Web Accessibility Specialist (WAS) certified by the International Association of Accessibility Professionals (IAAP). This audit was conducted on a representative sample of user flows, features, and components to assess conformance to the Web Content Accessibility Guidelines (WCAG) 2.2, Revised Section 508, and EN 301 549. This test was conducted on a representative sample of workflows including instructor feedback, alternative formats, and Administrator reports and configuration using manual and automated testing tools and techniques, and assistive technology. The tools and applications utilized throughout testing included NVDA, Google Chrome, Axe Dev Tools, WebAim's Contrast Checker, browser inspection tools, and Stylus browser extension.
