Introduction

This document describes the file format that Anthology Payroll R3 for Microsoft Dynamics requires to import local tax adjustment amounts and the procedure to import the file.

File Format

Anthology Payroll can import local tax adjustment amounts from Microsoft Excel spreadsheets. The import file must follow these specifications:

- File type: MS Excel spreadsheet
- Valid file name extensions: .xls or .xlsx
- Numeric value columns must be formatted as **Text** cells
- Worksheet tab name: Worker Payment Local Tax Adjs

Anthology Inc. can provide a blank template import file for use with local tax adjustment imports.

Rows

Each row in the import file describes one local tax adjustment record for one worker. If a worker has multiple local taxes and multiple adjustments, each one must be a new row.

The first row in the import file contains column headings. Column headings, must match existing field names in the specified order.

Columns

The following table lists the local tax adjustment fields that can be imported and the order of the columns. Optional fields can be empty. If your import file contains a header row, the column headings must match exactly to the specifications.

Anthology Inc. provides a blank template import file for use with local tax adjustment imports.

At minimum, the import file must include:

- · worker identification
- worker's pay group
- local tax code
- adjustment amount
- note text

Worker Identification

There must be at least one piece of information that identifies the worker associated with the imported record. If there is none, an exception is logged.

Payment Details

There must be some payment details specified to identify the payment to which the worker's local tax adjustment applies.

Local Tax Information

Local tax information is required. At minimum, the local tax code, the amount of the adjustment, and a reason for the adjustment are required.

Pennsylvania-specific Information

Local tax codes in Pennsylvania require additional information about the worker's address. These fields are ignored for any local taxes outside of Pennsylvania.

Import Local Tax Adjustment Amounts

To import local tax adjustments from an import file:

- 1. In the Anthology Payroll navigation pane, click **Journals > Local tax adjustments** to open the **Worker payment local tax adjustments** journal.
- 2. Click the Import button to open the Import local tax adjustments from an excel spreadsheet file dialog.
- 3. Browse and select the File name of the import file.
- 4. Select or set any processing options:
 - Active date and Expiry date: used to determine active records when looking up data on other Anthology Payroll forms for validation of import records. These fields are optional and if left blank, the import process uses the current date.
 - Import type: select Import new only to only import records that do not exist on the form. Select Import new and updates to import new records and update existing records on the form. Select Validate only (no import) to only validate the import file is in the correct format and import no records to the form.
 - **Import invalid data**: *No* to skip over any records in the import file that generate exception messages. *Yes* to import all records regardless of exceptions.
- 5. Click **OK** to import the file. An Infolog popup appears with a summary of the import process.
